1 The CloudSocket Website

CloudSocket's website (<https://www.cloudsocket.eu/>) is intended as the main point of reference for the project's progress. It aims to provide the visitors with a basic understanding of the goals and technical objectives of the project, as well as provide access to public material related to the activities of the project (leaflet, presentations, and public deliverables). It also includes a private area where only members of the project have access to and through which facilitates their collaboration.

The first-level structure of the site comprises the following:

1. **Welcome Page.**

The opening page provides a concise description of the main goals of the approach adopted by the project. It explicitly lists the four aspects that CloudSocket aims at addressing, namely (a) the exploitation of CloudSocket from the perspective of SME end-users, (b) the Broker role that could be played by an organisation operating the CloudSocket platform, (c) the technology perspective and types of tools to be used in the project, and (d) the research areas and goals that CloudSocket is addressing. 2. **Information about the Project.**

This section provides information about the main idea that the project aims to realize, the consortium composition and the specific use cases that will be developed in the course of the project.

3. **Documents.**

This section will host project-related publications, public deliverables and training materials that will be made available during the course of the project.

4. **Downloads.**

This section will offer downloadable versions of the tools that the project partners will develop which will be made available to the research and business community.




Figure 2 Web site section enabling the download of the software tools developed

5. Events.

Information on all project-organized events and events specifically targeted by the project consortium.




Figure 3 The Events section of the Project Website

6. FAQs.

The frequently asked questions related to the project on which answers are provided.

7. Contact.

Available contact information concerning the project coordinator, along with a contact form enabling the submission of questions about the project.

8. Internal.

This section comprises the private pages that only consortium partners have access to. CloudSocket members, including developers and researchers, use this area as an aid for collaboration in conjunction with other collaborative tools (svn, wiki).

Cloudsocket's web site will be maintained up-to-date following the progress of the project's work plan. The site is hosted on the IT infrastructure of the project coordinating organisation, BOC, and its development relies on the use of open-source software.
